My Gmail email is my personal email address. I don't feel comfortable using it for securing content, especially given the Google link has been shared in past emails with those of us who are state employees. I'm not a attorney, but I think the link would be like an email attachment...meaning it is subject to public information requests.

I wasn't part of roundtable in the first couple years until Wesley left to take the President role at Martin in July 2020. In my opinion, there isn't anything we have discussed that wouldn't be ok to be shared publicly. This work has been a thoughtful process. I think being transparent about the process would be a good thing and would strengthen the public perception of the work.

I'm sure the roundtable members who have a legal/attorney background could better speak to what would be subject to public information requests and the risks associated with the use of personal email addresses for those that do not have work Gmail.
